INTRODUCTION

The first statistical book provide a numerical picture which identify the number and types of complains submitted to the society in 1427H. 2006G, which reached (3575) complains. They were collected, classified and categorized by the Information, Statistics and Documentation Center in eight main categories such as, management law-suits, prisoners law-suit, workers lawsuits, family aggression lawsuits, Civil Affairs law-suits, personal affairs lawsuit and others, each category is classified into segments the personal affairs lawsuits, for example include, the following segments.

Divorce complains, nursing, alimony, deprive of guardianship, suspension abandonment, deprivation of seeing children, disinhent etc.

The goals aimed to be achieved by the society in limiting complains, classification and categorying in the annual statistic book, can be summarized as follows:-

- Upgrading the studies and reports issued by the society, by adding important source to information which the studies and reports depends upon through complains submitted to the society.
- Improvement of the society's planning for activities and programs. The planning starting from actual knowledge of reality is more effective in achieving required goals and results.
- Promote researchers and students to search in human rights law suits, the complains shown in the statistic book open wider horizons for researches in different areas including juristic, psychological, social, management, education economic and cultural studies
- Enrich the Juristic Library through providing field statistics, which the Juristic library is lack off.

- Support the concerned government bodies by preparing the international agreements reports to which the kingdom is joined in the human rights area. Often there report suffer shortage in some statistics or non.
- Give chance to the government and non government bodies to acknowledge weakness points in their performance, in particular the political sides, procedures, practices and obligation to apply regulations in order to improve its performance.
- Enable the society to make comparison for authority performance measure for the study year and the year before by using different parameters, as for certain authority co-operation percentage with the society, which is measured by the number of letters issued by the society and the number of replies thereto.
- Enabling the society to known and determine what can be considered as problem or phenomenon requiring making deep and comprehensive studies aiming to find solutions to end the repeated accusations, cease and remove its effects, this happens when individual complain is repeated for certain practice.

Finally, I extend my thankfulness to the Chairman of the Information, Statistics and Documentation Center. Ms. Sahela Zainul Abdeen Hamad for her effort in fulfilling this work, thanks for the monitory committee members and chairmen during the past three years, and to supervisors of the head quarters at Riyadh and the society branches in Jeddah, Gizan, Dammam and the law advisors for their efforts in studing companies and addressing the government and non-government authorities, follow up and the women employee at the Information, Statistics and Documentation Center.

**Vision and Mission** 

#### The National Society for Human Rights

The National Society for Human Rights was established in 18/1/1425 (9/3/2004) to protect the human rights and defend such rights in accordance with Islamic Sharia and the Government Basic Ruling Regulations as well as international agreements and charters that do not contradict Islamic Sharia.

#### Nature of the Society:

The society is a national body which is independent administratively and financially with no government connections. The society strives to defend the human rights inside and outside the Kingdom of Saudi Arabia, whether the subject of abuse is a citizen, expatriate or a visitor. The society cooperates with all government and non-government societies all over the world.

#### Vision of the Society:

Participation in building the society of justice and equality, and enforcement of law in accordance with the Islamic Sharia which calls for forgiveness and refraining from injustice, aggression and extremism.

#### Mission of the Society:

Protection of human rights, defending them and dissemination of human rights culture, and to take the necessary procedures to handle complaints and violations of human rights in order to limit and stop such practices and eliminate their effects, in addition to preparation of studies, conferences, symposiums and workshops, issue publications, declaration of opinions and preparation of reports.

# Definitions

The National Society for Human Rights since its foundation received a large number of cases that can be classified as follows:

#### 1) Administrative Cases:

These are cases received by the society against government bodies regarding issues review applications, Royal Pardon applications, Judgment execution claim, aggression to properties, objection to decision, Medical mistakes, Attack and assault from some administrative bodies, unemployment, compulsory deportation, job grade amendment request, discomfiture due to environment pollution or bad customer service, request to return to job, deportation request, transfer application, violence on the employee, Termination form jog due to accusation, Lengthy Procedures duration, Arbitrary transfer, Compensation request, request of compensations, claim for administrative or financial dues, non-regulatory pursuit, prevention from traveling due to administrative decision.

#### 2) Prisoners Cases:

These are cases received by the society regarding exemption from the remaining period, objection to prisoner deportation, health status tumble in prison, completion of Judgment and not released, complaint of non trial, application to transfer to other prison, deportation application, health care application, bad treatment, assault and violation of regulations inside prison, , prevention of visit, release application.

#### 3) Labor Cases

These are cases received by the society regarding complaints from persons subject to the Labor Law in relation to Compulsion to pay Iqama renewal amount, objection to decision, delay of appointment decision, deprive from promotion, decrease of job grade, compulsory deportation, sponsorship transfer application, psychical violence on laborer, termination for accusation, arbitrary termination, application for financial rights, compel laborer to do a job other than stated in the contract, force to work, compulsion for early retirement, application for health insurance, application for return to work, prevent the laborer to travel to his country

#### 4) Family Violence:

These are cases received by the society against one of the family members for Psychical & psychological violence, violence resulting from addiction, accusation & slander, Sexual abuse, sexual abuse, rape, prevention from education, prevention from work, prevention from salary, prevention from marriage, prevention from seeing mother, residence request.

#### 5) Personal Affairs Cases

These are cases received by the society regarding divorce, nursing, alimony, suspension & desertion, removal of guardianship, prevention from seeing children, prevention from inheritance, non acknowledgement of marriage and divorce demand

#### 6) Civil Affairs Cases:

These are cases received by the society regarding requests or complaints related to withdrawal of nationality, or request for nationality recovery, withdrawal of identification documents, non-addition of children, non authentication of some facts related to civil affairs.

#### 7) Judicial Cases:

These are cases received by the society regarding long period of review, objection to judgment, bad treatment from the Judge, compensation application, lengthy Procedures duration, prevention from travel due to a judgment sentence.

#### 8) "Other" Cases

This includes cases of disputes between individuals or companies, or requests for financial assistance, or requests to adopt certain suggestions, or to provide legal or Sharia consultations.




Figure (1) Total of received cases to the National Society for Human Right

Figure (2) Total of cases received by the National Society for Human Right as per the receiving branch



# Total of cases received by the National Society for Human Right as per applicant Gender





Figure (5) Total of Cases as per Gender, Head Office - Riyadh






Figure (6) Total of Cases as per nationality, Head Office - Riyadh

Figure (7) Total of cases as per basic classification , Head Office – Riyadh





Figure (8) Total of Cases as per Kingdom Administration Areas , Head Office - Riyadh

Figure (9) Total of cases as per Gender, Makkah Al Mukaramah Branch




Figure (10) Total of cases as per nationality, Makkah Al Mukaramah Branch



Figure (11) Total of cases as per basic classifications, Makkah Al Mukaramah Region Branch




Figure (12) Total of cases as per Kingdom administrative Areas, Makkah Al Mukaramah Region Branch





Figure (13) Total of Cases as per type Jazzan Branch






Figure (14) Total of Cases as per Nationality Jazzan Branch

Figure (15) Total of Cases as per Basic Classification Jazzan Branch





Figure (16) Total of Cases as per Kingdom Administration Area Jazzan Branch

Figure (17) Total of Cases as per type, Eastern Region Branch





Figure (18) Total of Cases as per nationality , Eastern Region Branch

Figure (19) Total of cases as per basic classification , Eastern Region Branch





Figure (20) Total of Cases as per Kingdom Administration Areas , Eastern Region Branch



Total cases received by the National Society for Human Rights as per branch since its foundation to the end of 1427H -2006





Figure (23) Total cases received by the National Society for Human Rights as per year



Total cases received by the National Society for Human Rights as per applicant Gender since its foundation to the end of 1427H-2006




Figure (25) Total cases received by the Society as per applicant nationality since its foundation to the end of 1427H -2006





Figure (27) Prisoners' cases revived by the National Society for Human Rights as per branch since foundation up to 1427H-2006



Figure (28) Laborer cases received by the National Society for Human Rights as per branch since foundation up to 1427H-2006




Figure (29) Family violence cases received by the National Society for Human Rights as per branch since foundation up to 1427H-2006







Figure (32) Judicial cases received by the National Society for Human Rights as per branch since foundation up to 1427H-2006





Figure (34) Total Administrative Cases as per Addressed Bodies since Foundation up to 1427H-2006



Figure (35) Total of prisoners cases as per addressed bodies since foundation up to 1427H-2006



Figure (36) Total of laborer cases as per Offending bodies since foundation up to 1427H-2006




Figure (37) Family violence cases as per Offending bodies since foundation up to 1427H-2006

Figure (39) Civil Affairs cases as per Offending bodies since foundation up to 1427H-2006





Figure (40) Total of Judicial Cases as per Offending Bodies since foundation up to 1427H-2006


Figure (41) Total of other cases as per Offending body since foundation up to 1427H-2006




